Personal Information Collection Statement of BOC-Prudential Easy-Choice Mandatory Provident Fund Scheme ("PICS")

中銀保誠簡易強積金計劃(「本計劃」)之申請人/成員明白及同意中銀國際英國保誠信託有限公司(「中銀保誠信託」,本計劃之受託人)可將收集的任何個人資料(不論從本申請表或經由積金易平台或以其他途徑收集)作以下用途:

Applicant / Member(s) of BOC-Prudential Easy-Choice Mandatory Provident Fund Scheme (the "Scheme") understand(s) and consent(s) that, any personal data collected by BOCI-Prudential Trustee Limited ("BOCPT", the Trustee of the Scheme (the "Trustee")) (whether collected in the application form or through eMPF Platform or otherwise) may be used by BOCPT for the following purposes:
