Thank you very much for your participation in the Scheme.

We would like to inform you of the following changes to the Scheme. Unless otherwise defined, capitalised terms used herein shall have the same meaning as defined in the MPF Scheme Brochure.

This table summarises the changes to the Scheme (the “**Changes**”). The Changes will take effect from 1 April 2026 (the “**Effective Date**”).

What are the Changes?

(a) **Reduction of the Fees payable to the Platform Company**

- The general fee level charged by the eMPF Platform Company Limited (“**Platform Company**”) will be reduced from 0.37% of NAV per annum to 0.29% of NAV per annum with effect from the Effective Date (“**Platform Fee Reduction**”).
- As a result of the Platform Fee Reduction, the aggregate management fees of each Constituent Fund will be reduced from the Effective Date as set out in the tables in section 1 of this notice.
- Apart from the reduction of the fees payable to the Platform Company, other fee components of the aggregate management fees of the Constituent Funds will remain unchanged.

Please refer to section 1 of this notice for details of the Changes.

How will the Changes affect the Scheme Participants?

- (b) The Changes will not have any adverse impact on the interests of the Scheme Participants.

Any actions required of the Scheme Participants?

- (c) No action is required of the Scheme Participants to effect the Changes.

1. Reduction of Fees Payable to the Platform Company

By way of background, the general fee level charged by the Platform Company will be reduced from 0.37% of NAV per annum to 0.29% of NAV per annum starting from the Effective Date.

In view of the Platform Fee Reduction,

- (i) the fees payable to the Platform Company at the constituent fund level of each Constituent Fund will be reduced to 0.29% of NAV per annum; and
- (ii) the aggregate management fees of the Constituent Funds will be reduced correspondingly as shown in the second table below.

and the reductions shall take effect from the Effective Date. Please refer to the relevant tables below for details.

Apart from the reduction of the fees payable to the Platform Company, other fee components of the aggregate management fees of the Constituent Funds will remain unchanged.

The relevant disclosure in the MPF Scheme Brochure and the Key Scheme Information Document of the Scheme (“**KSID**”) will be updated accordingly.
